Minutes of the Meeting


The IQAC meeting with all team members is held on **21st February** at **03.00 pm** in online mode (using Zoom platform).

The Agenda of the Meeting was related to the quality improvement in the **Academics, Students' activities, Industrial visits** and **evaluation** initiatives of the University.





1	Conduction of AAA audit for the session of July-Dec 2023.	Dr. Deepak Singh, the Deputy Director, has provided information about the upcoming AAA audit for the last session (July-Dec 2023). The audit is scheduled to take place from 23rd February to 20th March, 2024. During this period, designated Auditors will carry out the evaluation work to ensure a comprehensive assessment of the organization's activities.	Responsibility: IQAC, All HODs



		Dr. Dhanesh Singh has emphasized the importance of involving external members in the audit process. This suggests a commitment to transparency and impartiality in the evaluation. The inclusion of external members brings an additional layer of expertise and objectivity, contributing to the credibility of the audit results.	
2	Discussion on mentor mentee process.	<p>The mentor-mentee scheme, along with its comprehensive Statement of Purpose (SoP), has been thoroughly discussed. Vice Chancellor, Dr. R.D. Patidar expressed appreciation for the process. He instructed mentors to establish cordial relations with their mentees and actively, and address their issues and problems to contribute to the holistic development of students.</p> <p>Dr. Dhanesh Singh emphasized that mentors should not only provide guidance on academic activities but should also play a role in fostering the emotional growth and instilling human values in their mentees.</p> <p>Mr. R.P. Pandey suggested a practical approach by proposing that students selected in different JSP groups could actively support the placement process for final-year students. This collaborative effort aims to enhance the overall mentoring experience and create a supportive environment for the students.</p>	Responsibility: All mentors
3	Planning of activities for advanced-slow learner students for the current session.	The detailed discussion covered the identification process, activities, and reporting procedures for both slow and advanced learners. Dr. Siddharth Chakrabarti, Dean (Academics), highlighted various activities specifically designed for these two categories of learners. His emphasis on tailored activities suggests a commitment to addressing the diverse needs of students at different learning levels.	Responsibility: All HODs



By discussing identification and reporting processes, the institution demonstrates a proactive stance toward monitoring and facilitating the progress of learners across the spectrum.	
4	Activities for students' clubs for the current session.	<p>The university boasts a total of 13 student clubs. Vice Chancellor, Dr. R.D. Patidar conveyed the directive that each of these clubs should organize a minimum of two activities per semester. This initiative aims to foster a vibrant and engaging campus environment, offering students diverse opportunities for participation and enrichment.</p> <p>Mr. K.N. Pandey has suggested the introduction of a points-based assessment for various club activities, linking students' performance to this evaluation system. This approach not only incentivizes students to actively engage in club activities but also provides a tangible measure of their involvement and contribution. The points-based assessment is anticipated to motivate students to strive for higher scores, thereby enhancing overall student participation and the quality of club activities.</p>	Responsibility: All Club In-charges
5	Current status of NEP 2020 implementation at University.	Dr. B. P. Panda has informed the key points that are implemented at OPJU in line with NEP 2020. Some of the components are; Multidisciplinary studies through Choice Based Credit System (CBCS) , Academic Bank of Credits (ABC) , Courses comprises of Core Courses (CC), Ability Enhancement Core Courses (AECC), Skill Enhancement Courses (SEC), Value Added Courses (VAC), Generic Electives (GE), Discipline Specific Electives (DSE), Online learning - LMS ; proposed Nodal Centre for SWAYAM/NPTEL and Delivery by MOOC, Industry-Institute Collaboration, Academic	Responsibility: All HODs



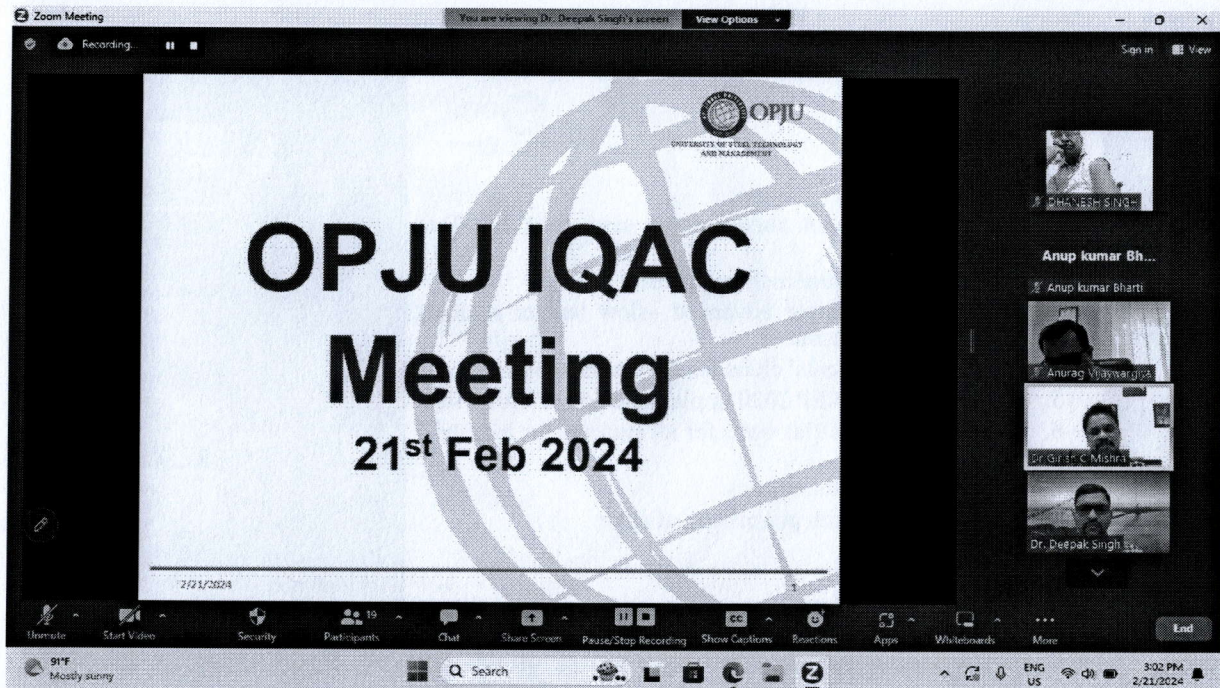
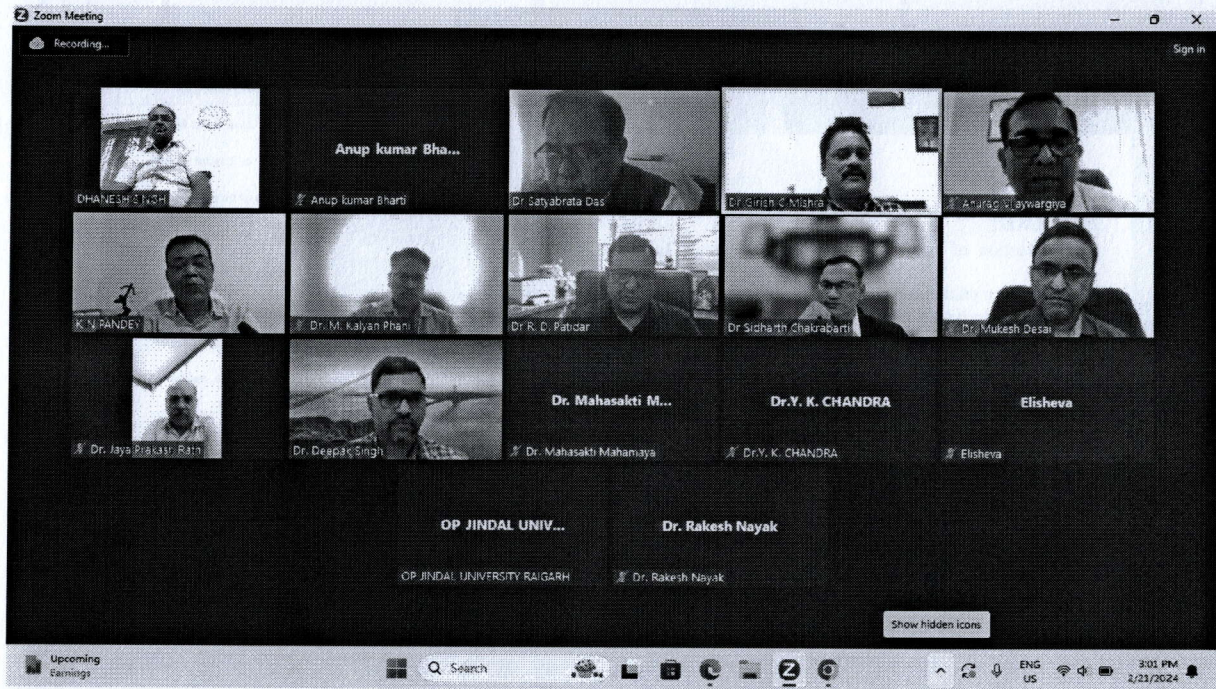
