2. Selected area to be covered under Pest Control activity.

- OPJU Campus
- Old & New Boys' Hostel, Girls' Hostel
- OPJU Colony, Old housing buildings and New Towers (All faculty & Staff of OPJU)

3. Description of activity to be carried out.

- (a) Mosquitoes, Cockroaches, Red & Black Ants, Bed Bugs Control.

This treatment comprise of a through insecticidal spray on the entire premises as stated above in point no.02, especially in all nook and corner and other vulnerable places harboring cockroaches, ants, spiders etc. However, special attention is to be given to toilets. The frequency of the treatment is on monthly basis.

- (b) Anti Larva Treatment.

This activity shall be carried out to have control over the breeding of the mosquito. Special care is to be given to surrounding areas i.e. drains, stagnated water place, open walls and septic tanks and all probable breeding points. The frequency of the treatment is once in a week.



(c) Fogging operation.

This activity shall be carried out in all open area and surrounding area as stated in point no.02. Frequency of the activity is fortnightly basis.

(d) Rodent Control (Mice & bandicoots).

This activity consists of baiting, caging and glue trapping of rats in dwelling places, stores and food processing areas. The above practice will not only prevent damage of electric wire, cables, leather, plastics, clothes, papers but also protect contamination/infection due to presence of rodents. Frequency of the activity is on required basis.

(e) Removal of Honey Comb.

Removal of Honey Comb is to be carried out by killing and removing bees through application of required chemicals, arranging necessary accessories to reach at the locations up to the height of 10 meters. Frequency of the activity is on need base.

04. Other terms & conditions

- (f) All materials, consumables, tools and tackles required for the Pest Control activities is in the scope of the contractor.
- (g) Inspection of the work is to be carried out by the administrative department of the OPJU from time to time.
- (h) Contractor will maintain the monthly record of the work done and submit the same to the Administrative Department for verification/certification.
- (i) Contractor has to submit the bill on or before 5th of every month for the preceding month in the Accounts Department duly signed by the days from the date of receipt of the same. The invoice shall indicate address of the service provider, PAN number, place of service rendered.
- (j) There will not be any price escalation at any point of time during the execution of the contract.

05. Force Majeure - In case of any failure or delay in performance of any obligation under this Agreement due to events of Force Majeure which shall for purpose of the Agreement include but not be limited to Public enemy, Fire,



Earthquakes, Storms, Typhoons and Floods, War, Blockage, Strike, Disturbances, Riot, Lockouts, Labour disputes (other than caused by the Service Provider's employees or contractors or agents), Land Slides, Epidemics, pandemic, Sabotage and change in law or regulation or other Government action directly affecting this Agreement or any other cause beyond a Party's control, the parties will be exempted from the liabilities that would otherwise result from its delay or failure.

06. Dispute Settlement - Except as otherwise provided elsewhere in the contract, if any dispute, difference, question or disagreement or matter whatsoever, shall, before/during/after completion or abandonment of work or during extended period, hereafter arises between the parties, as to the meaning, operation or effect of the contract or out of or relating to the contract or breach thereof, shall be referred to the committee appointed by the university. The award given by the committee shall be binding on the parties.

07. Jurisdiction - The service provider shall hereby submit to the jurisdiction of the court situated at Raigarh, Chhattisgarh for the purpose of actions and proceedings arising out of the contract and the court of Raigarh shall have the sole jurisdiction to here and decide such action and proceedings.
